Request made under the Official Information Act 1982

Thank you for your email of 26 March 2015 requesting information on bridge upgrades and/or roading works in Northland over the past six years. We sought your refinement of your request and on 8 April 2015 you resubmitted your request for:

All advice, research and other relevant data that the NZ Transport Agency has prepared for government ministers, other MPs or Treasury between 26 March 2014 and 26 March 2015 relating to:

- *the announcement to upgrade the 10 bridges in Northland*
- *significant roading projects in Northland*
- *Puhoi to Wellsford Road of National Significance.*

The following documents fall within the scope of your request about Northland bridges and significant roading projects. Information which is out of the scope of your request has been redacted.

Attachments 8, 9 and 10 were provided in response to requests from the Office of the Minister of Transport about upgrading the Northland bridges. The Transport Agency was not asked to provide advice to the Minister of Transport about whether to proceed with upgrading the Northland bridges.
