Dear Vanessa

The SH1/SH3/SH26 Hamilton City Speed Review was implemented on 10th December 2021. This Speed Review decision and approval included an Intersection Speed Zone at SH3-Raynes Road intersection, but for logistical reasons the ISZ was not able to be implemented at the time of the remainder of the Speed Review. The intention was to gazette a bylaw when the installation issues had been resolved and an implementation date could be confirmed.

Since then the Speed Rule 2022 come into force, which imposes different requirements in terms of the legal instrument to confirm the speed limit. It is proposed to follow the process available pursuant to clause 2.6 of the Speed Rule whereby approval is sought from the Director of Land Transport.

We note that an ISZ VSL R1-2.1 option B is to be instated pursuant to Land Transport Rule: Traffic Control Devices 2004 (April 2021) - Speed Limit Signs for New Setting of Speed Limits Rule 2022 and in compliance with the requirements detailed in Traffic Note 62.

Waka Kotahi (RCA) is now in a position to be able to implement the ISZ, being:

It is proposed to implement the ISZ as soon as feasible once it is approved by the Director
