

New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2021/9

Pursuant to section 61(3) of the Government Roading Powers Act 1989, and the Land Transport Rule: Setting of Speed Limits 2017, the NZ Transport Agency hereby makes the following bylaw.

Bylaw

1. Title and Commencement

This bylaw is the New Zealand Transport Agency (Speed Limits on State Highways) Amendment Bylaw 2021/9 and will come into force on and from 11 August 2021

2. Amendment

Speed Limit (km/h): A variable speed limit of 30, 40, or 60km/h.

When a variable speed limit sign installed on the section of State highway displays:

the numerals “30”, the speed limit is 30km/h;

the numerals “40”, the speed limit is 40km/h;

the numerals “60”, the speed limit is 60km/h (normal operation)

The speed limit may be varied to manage the safe flow of traffic as required for:

- a. changing traffic volumes and to ease congestion;
- b. emergency or temporary traffic management;
- c. different numbers and types of road users or different traffic movements; or,
- d. changing environmental conditions.
