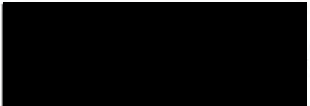

On FRIDAY 05/09/14 13:15-13:30 HAO [REDACTED] FROM NAPIER DOING A REQUALIFICATION RESTRICTED TEST HE WAS TERMINATED FOR 2x CRITICAL ERRORS FIRST STAGE. WHEN BACK AT AA CORONA BAY TOLD APPLICANT HE HAD FAILED HIS TEST HE BEGAN TO GET ANGRY WITH ME SAYING I WAS A LIAR AND THAT HE DID LOOK BOTH WAYS RAILWAY CROSSING, WHICH HE DID NOT! ON THE WAY BACK YES HE DID $\frac{1}{2}$ LOOK! BUT TEST WAS OVER AT THAT STAGE. I TRIED TO CALM HIM DOWN BUT NO EFFECT.
